**Reservations and Cancellations:** Reservations are only considered to be finalized after the full payment has been received. Full payment must be received 30 days prior to trip start. If for any reason a reservation needs to be cancelled please notify Gruppetto Tours as soon as possible. Payment less 100% of the deposit will be refunded if cancellations are done 30 days prior to trip start.

**Participant Responsibility:** Clients of Gruppetto Tours should have travel insurance covering the duration of the tour. All riding clients must wear a cycling helmet at all times while cycling. Gruppetto Tours is only responsible for those expenses explicitly mentioned in the conditions of the tour package; clients are responsible for all other expenses. Gruppetto Tours reserves the right at any time to ask any client to leave the tour they do not abide by tour rules or if their personal conduct and behavior is troublesome to other clients or third parties.

**Limitations of Liability and Release:** Gruppetto Tours is not liable and will not assume responsibility for any personal injury, death, property damage, cancellations or delays during the period of the tour. All clients accompanying Gruppetto Tours should have personal travel insurance covering all accidents, personal injury, property damage, loss of luggage, delays, cancellations and third party culpability.
